### Form 14 Contractor Declaration On Safety and Security

Builders shall strictly abide by the "Safety regulations on Large-scale Social Activities in Beijing", "Fire Safety regulations on Exhibition", "Regulations in the Construction of Exhibition Facilities in China National Convention Center", "The Detailed Implementation Rules in the Construction of Exhibition Facilities in China National Convention Center ", and other relevant rules and regulations, also put all their activities under the construction management and supervision ,inspection of relevant department of China National Convention Center Group Corporation (hereinafter referred to as CNCC) to ensure the safety to the booths and personnel.

Before construction the builders shall undergo the procedures of registration of their construction qualifications, construction blueprints for approval, etc. in accordance with the relevant rules and regulations of CNCC, and pay the related fees.

The builders are responsible for the safety and fire prevention during construction period where they should appoint a person in charge of safety and prevention onsite.

The booth structure should be firm and safe .Fire-retardant or fire-proof materials should be used in booth construction, and using the elastic cloth and textile cotton fabrics for decoration is prohibited. Wood structures need to be sprayed with fire retardant coating before entering the site.

Two-storey booth is prohibited as the relevant regulations.

Contractor shall carry fire extinguisher by your own and according to the rule of two fire extinguishers per 50sqm.

The structure of the booth is not allowed to block the fire protection facilities in the exhibition hall (including the red fire protection ditch cover of the first ditch west of the column in the hall), electrical equipment, emergency exit and audience access. Under the fire shutter door of the exhibition hall, no exhibition racks, booths, integral platforms and various cargoes shall be built. The pillars of the exhibition hall where the fire shutter doors are located are strictly prohibited from taking any form of wrapping and covering to ensure the smooth lifting of the fire shutter doors. Keep a certain distance between the back wall of the booth and the wall of the exhibition hall. The distance should not be less than 60 cm for maintenance personnel to enter. The width of the passage leading to the exit, first aid, fire fighting device and fire alarm point is not less than 140 cm.

If the temporary facilities of the venue are adjacent (such as pillars), the contractor must measure the actual amount before construction.

The heights of the booths with special equipment should not exceed the limits. The height limit is 5m in Hall 1-4 and 3.5m in Hall 5-6.

The outdoor booth shall be well protected against wind and ensure the strength, rigidity, stability and local stability of the booth structure. If there is a bad weather such as strong winds, the construction unit must have an emergency plan in advance to ensure safety.

Use tempered glass for decoration and ensure its toughness and thickness (for glass walls, the minimum glass thickness is 8mm). The installation of glass shall be suitable and reliable. When installing glass, put glass pieces into metal frames or fix them with special metal pieces, with elastic materials as cushions between metal and glass for safety. Put obvious warnings on big pieces of glass. Don't fix pillars and walls on glass-made floors, fix them on the solid floors under

them instead.

Materials used for building booths shall be in conformity with the standards of materials used for temporary buildings set by the relevant government branch and with the standards of environmental protection. In addition, the materials chosen shall reflect the characteristics of the exhibition.

No smoking in the exhibition hall. No flammable, exposable materials and no fire during the construction.

Booths must be roofed by less than 100% (including 100%) so as not to influence or/and block the fire alarm system.

Construction workers must show correspondent entrance permission cards and professionals must show correspondent certificates when entering the center for construction.

During the construction of booth, all kinds of waste products such as construction garbage should be cleaned at any time. The materials for the construction of the booth should be placed neatly in this booth. It is strictly forbidden to occupy the fire channel and keep the channel in the hall unblocked. The warehouse where the articles are stored shall not be set up in the hall, or the booth materials and construction tools shall be stored in the public area. Otherwise, the venue shall have the right to take the confiscation and reserve the right to deduct the construction deposit.

Neon lights and **high temperature lamps are strictly prohibited** as decorative lighting for the stand. Electrical equipments and materials (such as lightings) must have CCC on them and shall be installed and used according to the standards and procedures concerning the use of electrical set by Beijing municipal government. Electrical equipments shall be connected by double insulated cables and the terminals must be kept in insulated boxes without been exposed.

Power is supplied for 24 hours by CNCC, but it is not for unremitting use.

Builders shall not use the fixed facilities (such as power distribution boxes, water supplies, gas supplies, etc.) in the exhibition hall. Lightings, sockets, distribution box and the like for outdoor use must be water-proof, and electrical equipments for outdoor use must be placed with water-proof measures.

If the contractor has high-altitude operations, it must arrange for personnel with high-altitude operations to work at heights, with helmets and safety belts, high-hanging and low-use methods, and construction personnel must be under the supervision to ensure construction safety. The lifting equipment is provided by the contractor, and it is required to wear a safety helmet and a safety belt. The method of high hanging and low use is required, and the construction personnel must be under the supervision. It is strictly forbidden to work out the working platform.

Before using the lift truck, check whether the lift frame is freely up and down, the screws should be firm, the steel wire rope is free from corrosion and the lubrication is good.

Construction personnel must be at least 18 years of age to perform high-altitude construction. Before boarding or entering the lifting platform, operators should wear non-slip shoes. The upper and lower garments should be tight and neat and must assess the potential hazards in the construction area to confirm that there are no safety hazards only construction work can be done.

The lift truck should be level on the ground. When the local surface is not flat, the body should be leveled. It is not allowed to use the lift truck on the steep slope.

The operator should check that the safety tools (hardhats, safety belts, etc.). They must be safe and reliable, and it is strictly prohibited to take risks.

When using the lift truck, the stabilizer bracket must be opened to check the stability of the bracket and prevent the lift truck from sliding on its own.

The staff at the top of the lift must work inside the working platform, and must not ride on the fence and stand on the fence. It is strictly forbidden to lift and lower the rated load beyond the working platform.

All kinds of ladders or other high-rise items are not allowed on the top platform of the lift truck. When the staff is working outside, they must ensure that their feet touch the ground. Otherwise, the lift truck should be moved.

When the lift truck is raised, it should be noted that the specified safety distance should be maintained with the overhead wires; when the person responsible for manual lifting is operating, the face should flash on the side of the wire rope to prevent the wire rope from suddenly breaking and dangerous; it is forbidden to use the electric lifter outdoors in rainy days.

The electric lift truck should ensure good grounding, the protective layer of the power cord should be complete, and the copper wire should not be exposed; the power cord should be protected when it crosses the road.

When the lift truck staff transfers tools or materials up and down, it cannot be lifted by the method of throwing, and the staff on the platform should prevent the tools or materials from falling and hurting pedestrians.

There must be a guardian under the lift truck operation, and it is strictly forbidden to enter the work area.

In the venue, only the main steel beam (I-beam) can be hung, and the aerial sling or wire rope must be used for hanging, and the steel beam protection should be done. The weight of each lifting point should not exceed 400 kg.

For outdoor work, if there is a strong wind of 5 or above, it is forbidden to work in the open air. Construction workers shall self-assess potential safety hazards to the construction area and confirm the safety before construction work

After the opening of the exhibition, the contractor must leave the on-site safety person in charge and the full-time staff on duty.

When the museum is dismantled, the contractor shall withdraw all the construction materials from the exhibition hall and clean them. It is strictly prohibited to be stacked in the booth or the outer area of the exhibition hall.

The venue reserves the right to impose special restrictions on special circumstances and has the right to enter the booth for inspection.

The contractor shall not abandon any waste and build waste in the trench of the venue.

The contractor shall be responsible for all safety responsibility accidents caused by violation of the above-mentioned regulations during the construction, dismantling and transportation of the construction unit, such as casualties, fires and damage to the buildings and facilities of the venue, and shall bear the responsibility to the venue and all the reputation and economic losses caused.

The contractor shall strictly follow the above requirements and relevant rules and regulations for construction. If there is any violation, CNCC will deduct the corresponding construction deposit according to the circumstances.

The legal person entrusted by the contractor of this booth has carefully read the construction safety responsibility letter and the relevant rules and regulations mentioned above, and guarantees strict compliance with relevant safety management regulations. Otherwise, the company is willing to assume full responsibility in case of safety problems.
